COMMUNITY RECREATION SCHOLARSHIP FUND

Goal: To assist athletic groups in our greater Gig Harbor and Key Peninsula community thought grants to support enrollment fees and other costs that will enable disadvantaged youth to participate in sports and recreational programs.

Applicants: Grants are limited to athletic organizations working in the greater Gig Harbor, Key Peninsula and Fox Island geographic area.

Grant: Grant amounts may vary from \$500 to \$1,500.00.

Process: To be eligible for consideration a letter of inquiry (LOI) form must be completed, submitted and approved prior to submitting a full proposal, which will require additional information.

Letter of Inquiry: List agency/organization information and non-profit status. State project proposal and projected outcomes. State how project aligns with goals of the grant. Amount of money requested One or two pages with 10 point font. A copy of the organization's IRS 501(c)3 letter of determination must be attached.

Application Deadline: Currently there are no deadlines for the Community Recreation Scholarship grants; LOS's received will be reviewed as received, beginning late 2014.

Note: All LOI submissions will be reviewed within 2 weeks of receipt. Viable applicants will be invited to submit a full proposal.
